It is the obligation of the attorney representing the party to enter the QDRO with the Court and send us a certified copy of the QDRO. Occasionally, certain plan administrators require a certified copy of the Decree along with the certified copy of the QDRO. In these instances we will advise you in advance that a certified copy of the decree is needed with the QDRO. We guarantee that all QDRO's will be approved by the Plan Administrator. If, for any reason, the QDRO requires changes or revisions, we will make the change or revision at no extra cost. However, the entry of the revised plan with the Court is the responsibility of the attorney and any fee by the court (such as filing fees), are to be borne by the client. Our fee does NOT include any fee charged by the plan administrator. Such fees are to be borne by the parties and are usually taken directly out of the proceeds of the plan itself. It is the responsibility of the attorneys and the parties to review the QDRO and ensure that it complies with the intent of the parties and/or Court prior to submission to the Court.
